- Therapist will be available to clients and will schedule sessions with consideration of academic schedules including consideration of sports, activities, and club responsibilities.
- Creates and implements treatment plans that are developmentally appropriate, strength-based, skill-oriented, and family-driven.
- Works collaboratively with parents/guardians, staff members, and members of the client's treatment team.
- Provides consultation services to the school staff to support the overall mental health goals of the school and client as appropriate and as needed.
- Adheres to the policies, procedures, and regulations by governing and licensing bodies for the services being delivered.
- Maintains appropriate boundaries and confidentiality with clients and families.
- Travel will be required. The ability to conduct TeleHealth sessions will be required.

- Licensed as an Independent Mental Health Practitioner (LIMHP), Mental Health Practitioner (LMHP) or provisionally licensed mental health practitioner (PLMHP) in the state of Nebraska.
- Clinical experience working with youth and families preferred.
- Ability to meet agency's conditions of employment regarding health status and clearance with the Nebraska Child Abuse/Neglect Central Registry, criminal history check, and various other agencies depending on specific job responsibilities.
- Ability to write material in comprehensive form.
- Knowledge of community resources.
