



## School-Based and Outpatient Mental Health Therapist (Part-Time)

CRCC is looking for a dedicated, qualified part-time School-Based and Outpatient Mental Health Therapist to work within the Bellevue and Papillion LaVista School Districts as well as the CRCC Centers. This person will be responsible for providing individual, family and group therapy to assigned clients in the school and outpatient settings. Advancement to full-time employment may be an option with caseload growth.

### **CRCC Mission and Values**

CRCC is a local non-profit organization dedicated to providing comprehensive services to children with special needs to help them reach their highest potential. CRCC values Quality Care for Children, Family Involvement, and Staff Excellence. CRCC's work environment is energetic and team-oriented.

### **Essential Functions/Responsibilities**

- Provides direct mental health services, individual/family/group therapy, to children and adolescents within the Bellevue and Papillion La Vista School Districts. The therapist may also be assigned outpatient clients at either of the CRCC Center locations.
- Therapist caseload will consist of students, grades 7 to 12. Outpatient clients will range from age 3 to 25.
- Therapist will be available to clients up to 20 hours per week and will schedule sessions with consideration of academic schedules and extracurricular activities.
- Creates and implements treatment plans that are developmentally appropriate, strength-based, skill-oriented, and family-driven.
- Works collaboratively with parents/guardians, staff members, and members of the client's treatment team.
- Provides consultation services to the school staff to support the overall mental health goals of the school and client as appropriate and as needed.
- Adheres to the policies, procedures, and regulations of governing and licensing bodies for the services being delivered.
- Maintains appropriate boundaries and confidentiality with clients and families.
- The physical location of this position is within the above stated school districts and CRCC Centers.
- Travel will be required. The ability to conduct Telehealth sessions will be required.

### **Minimum Qualifications**

- Active Mental Health Practitioner's License in the state of Nebraska (LIMHP, LMHP, PLMHP).
- Experience working with youth and families preferred.
- Knowledge of and ability to implement individualized behavioral intervention programs and family-centered, strength-based services.

- Ability to meet agency's conditions of employment regarding health status and clearance with the Nebraska Child Abuse/Neglect Central Registry, criminal history check, and various other agencies depending on specific job responsibilities.
- Ability to write material in comprehensive form.
- Knowledge of community resources.

- PLMHP required supervision provided at no cost to therapist.
- Equipment necessary for role is provided.
- Professional liability insurance is provided.
