### **Qualifications:**

- Bachelor's Degree in Education or related field is preferred. In lieu of Bachelor's degree, will accept Associates degree in Education or related field and/or two years working with children in a school or childcare setting required.
- Ability to meet conditions of employment regarding health status and clearance with the Nebraska Child Abuse/Neglect Central Registry and/or Adult Abuse/Neglect Registry, Omaha Police Department, criminal history check, and fingerprinting.
- Previous work experience with pre-school children, preferably special needs children.
- Must be able to complete 12 education hours (CEU) each year.
- Possesses understanding, patience, and flexibility in dealing with clients, parents, and team members.

- Ability to demonstrate successful completion of Personal Care Aide Training including a PowerPoint, quiz, and competency demonstrations signed by a Registered Nurse as required by Children's Day Health Services regulations.
- Willing to increase knowledge in fields of endeavor.
- Ability to develop and implement written lesson plans.
- Must be agile enough to perform the job as a caretaker of young clients.
- Ability to lift up to fifty pounds and practices 2 person lifting for clients over 50 pounds or when necessary.
